

CALVARY CHAPEL EASTSIDE

Rules on Marriage and Facility Use

- 1.) Calvary Chapel Eastside and its pastors perform marriage ceremonys as an "accommodation" to the Body of Calvary Chapel Eastside. NOT an obligation.
- 2.) Calvary Chapel Eastside and its pastors only perform Biblical and Legal "Marriage" Ceremonies. We do not, under any circumstances, provide any other type of ceremony binding two people together. This includes, but is not limited to, Civil Unions.
- 3.) Calvary Chapel Eastside and its pastors hold unwaveringly to the Biblical view of Marriage. This is outlined in Genesis 2:18-24 as the joining of one biological women and one biological man. Any union outside of this Biblical direction will not entertained in any way.
- 4.) Calvary Chapel Eastside and its pastors only perform wedding ceremonies for active members/attendees of Calvary Chapel Eastside. An active member is one who has been in attendance a Calvary Chapel Eastside for a minimum of 2 months and plans to continue attending for the foreseeable future. This allows pastoral staff to get to know the couple and be available to them for counseling following the ceremony, should it be needed.
- 5.) Calvary Chapel Eastside and its pastors reserve the right to refuse to perform a wedding ceremony if they feel, from a Biblical perspective, that it would not be in the best interest of the two individuals involved. This choice can happen at "any point" in the meeting/counseling/pre-marital process.
- 6.) Calvary Chapel Eastside and its pastors may require action by the couple before they agree to perform a wedding ceremony. This can be anything from individual counseling for one or both to a change in living arrangements. These requirements could come up at any point in the meeting/counseling/pre-marital process.
- 7.) Calvary Chapel Eastside does not "rent out" the church facilities for weddings. The church is the property of God and may be used freely by those who agree with the above rules and are regular attending members of Calvary Chapel Eastside. We do, on the other hand, encourage those who are to be married to seriously consider giving a financial gift to those who gave of their time to help make your wedding a success. This is proper etiquette, but it is not required.
